

ORDER IN ORIGINAL

1. Any person/party aggrieved by this order may, under Section 15 of the Foreign Trade (Development and Regulation) Act, 1992(as amended) file an appeal against the same with the appropriate authority viz., The Additional Director General of Foreign Trade, New Delhi within 45 days.
2. The DGFT headquarters, New Delhi had reported that the firm M/s Ambassador Garments (Pvt) Ltd., Plot No.A-11, Madras Export Processing Zone, Chennai 600 045 had availed benefits under the Garment Export Entitlement Policy from the Ministry of Textiles and had defaulted in the export performance against the quota allocated against the year 1997 and had breached the conditions of Legal Undertaking executed by them with AEPC.
3. Accordingly, an amount of Rs.319808/- (Rupees Three Lakhs Nineteen thousand eight hundred and eight only) is due to be recovered from the firm as ordered by Apparel Export Promotion Council. The Directorate General of Foreign Trade, New Delhi vide their letter dated 01/91/180/1194/AM 10 EC dated 27.8.2015 has in turn, has now ordered for action against the firm for the recovery of the said amount from the firm.
4. In view of the above report, a show cause notice was issued to the firm and its directors on 11-1-2016 calling upon the firm and its directors to show cause as to why action should not be taken under the Foreign Trade (Development & Regulation) Act, 1992 read with FT(D&R) Amendment Act 2010 for suspending the IEC of the firm, for placing the firm under the Denied Entity's List and for the consequential action under the Act. The Notices sent to the firm and its director returned undelivered with remarks by the postal authorities as 'Left without instructions'. No other addresses were available in the IEC data base for extending another opportunity to the firm to defend themselves.

5. Under these circumstances, the undersigned is constrained to take action under the provisions of the Foreign Trade (Development & Regulation) Act., 1992 based on the report of the DGFT and Ministry of Textiles. The firm and its Directors are guilty of violating the conditions of the benefits extended to the garment exporters under Garment Export Entitlement Policy of the Ministry of Textiles thereby liable for recovery of the said amount of Rs.139808/- together with penal interest of 18%.
6. I hereby order recovery of the sum of Rs.139808/- together with penal interest of 18% from the defaulted firm M/s Ambassador Garments (pvt) Ltd., Plot No.A-11, Madras Export Processing Zone, Chennai 600 045 under section 11(6) of the Foreign Trade (Development & Regulation) Act, 1992 read with FT(D&R) Amendment Act 2010.
7. In view of the default, I further order for suspension of the IEC No.0488036623 granted to the firm under Section 8(1) of the Foreign Trade (Development & Regulation) Act, 1992 read with FT (D&R) Amendment Act 2010.
8. The firm is also place in Denied Entity List and no further License shall be granted to the firm or to its Directors as per provisions of Hand book, read with Clause 7 (1) of the Foreign Trade (Regulation) Rules ,1993 read with guidelines for maintaining the Denied Entity List (DEL) issued under F.No.18/24/HQ/99-2000/ECA.II dated 31.12.2003 from DGFT., New Delhi.

This order is issued without prejudice to any other action that may be taken under any other Act, Rules or Regulations in force.
