ORDER-IN-ORIGINAL

- 1. Any person/party aggrieved by this order may, under Section 15 of the Foreign Trade (Development and Regulation) Act, 1992 & notification no. 21 (RE-2013)/2009-2014 dt. 13.6.2013file and appeal against the same to the appropriate authority viz. The Additional Director General of Foreign Trade, Office of the Additional Director General of Foreign Trade, 4th Floor, Shastri Bhavan Annex, 26, Haddows Road, Nungambakkam, Chennai 600006 within a period of forty five days (45 days) from the date of service of this adjudication order together with a copy of this order and a complete set of evidence in the form of Annexure to the appeal relied upon in support of the appeal.
- 2. Any person/party desirous of filing an appeal against this order shall deposit the penalty amount and produce proof of payment of penalty amount along with the appeal to the Appellate Authority failing which the appeal is liable to be rejected for non-compliance of the provisions of Section 15 of the Foreign Trade (Development and Regulation) Act, 1992.
- 3. The penalty amount is to be deposited in an authorized bank of Central Bank of India under the Head of Account "1453 Foreign Trade & Export Promotion Minor Head 102 other receipts fines, Penalties etc.". The bank receipt must show the name of Dept. viz. Directorate General of Foreign Trade. The bank receipt drawn in favour of Pay & Accounts Officer (Foreign Trade), Chennai.
- 4. Evidence of payment of penalty is required to be furnished to the Adjudicating Authority within forty five days (45 days) from the date of service of this Adjudication Order, failing which the Importer-Exporter Code Number of the persons/companies/ other entities concerned is liable to be suspended under the provisions of Section 11(4) of the foreign Trade (Development & Regulation) Act, 1992 without making any further reference to them.

- 5. M/S.Alisha Modern Rice Mill, 161/3A-3B, Kottampatty Road, Dindigul 624002 had obtained an EPCG licence no.3530000665 dt: 22.09.2004 for duty saved amount of Rs.1,36,527 for import of capital goods with an export obligation to Rice worth US\$ 23,667 within a period of 8 years from the date of issue of authorization. IEC no allotted to the company is 3504002930.
- 6. M/S.Alisha Modern Rice Mill, Dindigul had not submitted statement of exports evidencing fulfillment of export obligation in spite of this office letter dt: 22.08.2016.
- 7. Notice Under Section 14 for action under section 11 (2) (3) (5) (6) & 11- (7) of FT (DR) Act 1992 as amended in 2010 and for Action Under Para 5.17 of HBP & action under Rule 7(k) of the Foreign Trade Regulation Rules, 1993 was issued to the Firm and it's Proprietor with personal hearing on 02.11.2016 at 11am to 1pm. There was no response from the Firm. The notices addressed to the Firm and its Proprietor were returned undelivered by postal authorities. Hence M/S.Alisha Modern Rice Mill was placed Under Denied Entities List vide letter dt: 29.11.2016
- 8. In the circumstances, the undersigned is now fully convinced that the Licensee and its Proprietor is guilty of violating the conditions of the licence in question thereby liable to a penalty under Section 11 (2) of Chapter IV of Foreign Trade (Development and Regulation) Act, 1992. In exercise of powers vested in me vide Notification No. SO (E) dt.17.4.2009 issued by DGFT, New Delhi in F.No. 18/27/HQ/06-07/ECA-II, I hereby impose a penalty of Rs.13,00,000 (Rupees Thirteen lakhs only) on the Licensee and its Proprietor towards non-fulfillment of export obligation in full against the subject licence.

I further order that no further authorization shall be issued to the firm/Company or to any other firm/Company in which the Proprietor of this firm/Company is directly or indirectly involved in the day-to-day activities of that firm/Company as per Provisions of Handbook read with Rule 7(1) of the Foreign Trade (Regulation) Rules, 1993.

This order is issued without prejudice to any other action that may be taken under any other Act, Rules or Regulations in force.
