1. Any person/party aggrieved by this order may, under Section 15 of the Foreign Trade (Development and Regulation) Act, 1992 & notification no. 21 (RE-2013)/2009-2014 dt. 13.6.2013 file and appeal against the same to the appropriate authority viz. The Additional Director General of Foreign Trade, Office of the Additional Director General of Foreign Trade, 4th Floor, Shastri Bhavan Annex, 26, Haddows Road, Nungambakkam, Chennai – 600006 within a period of forty five days (45 days) from the date of service of this adjudication order together with a copy of this order and a complete set of evidence in the form of Annexure to the appeal relied upon in support of the appeal.

2. Any person/party desirous of filing an appeal against this order shall deposit the penalty amount and produce proof of payment of penalty amount along with the appeal to the Appellate Authority failing which the appeal is liable to be rejected for non-compliance of the provisions of Section 15 of the Foreign Trade (Development and Regulation) Act, 1992.

3. The penalty amount is to be deposited in an authorized bank of Central Bank of India under the Head of Account "1453 Foreign Trade & Export Promotion Minor Head 102 other receipts fines, penalties etc." The bank receipt must show the name of Dept. viz. Directorate General of Foreign Trade. The bank receipt drawn in favour of Pay & Accounts Officer (Foreign Trade), Chennai.

4. Evidence of payment of penalty is required to be furnished to the

Adjudicating Authority within forty five days (45 days) from the date of service of this Adjudication Order, failing which the Importer-Exporter Code Number of the persons/companies/ other entities concerned is liable to be suspended under the provisions of Section 11(4) of the foreign Trade (Development & Regulation) Act, 1992 without making any further reference to them.

- 5. M/s. Sri Naga Nanthana Mills Ltd., 51, Avaniapuram Bye Pass Road, Madurai – 625012. obtained an EPCG authorization No. 3530002692 dated: 21.6.2007 for a duty saved value of Rs. 5,26,510 for indigenous procurement of Capital goods with export obligation to export Cotton Yarn and synthetic yarn for FOB value US\$ 1,20,953 within a period 8 years from the date of issue of authorization. IEC no allotted to the Company is 3594005178.
- 6. The Export Obligation period expired on 20.6.2015. Letter dt: 23.6.2015 was issued calling for E.O. documents. There was no response either from the company or from the directors.
- 7. Notice dt: 20.7.2015 under section 14 for action under section 11 (2) (3) (5) (6) & (7) of FT (DR) Act 1992 as amended in 2010 and for action Under Para 5.17 of HBP & action under Rule 7(k) of the Foreign Trade Regulation Rules, 1993 was issued to the firm and its Partners with personal hearing on 30.7.2015 at 10 a.m. In response to SCN, M/s. Sri Naga Nanthana Mills Ltd. vide letter dt: 29.7.2015 asked for alternate date for personal hearing. Vide letter dt. 9.10.2015 personal hearing was fixed on 15.10.2015 at 10 a.m. Again as requested vide this office letter dt. 15.10.2015 personal hearing was fixed on 1.1.2016 at 9.30 a.m. Vide letter dt. 31.12.2015 M/s. Sri Naga Nanthana Mills Ltd. submitted copy of decision of EPCG Committee Meeting held on 23.11.2015. As decided by EPCG Committee, this office vide letter dt. 30.3.2016 requested M/s. Sri Naga Nanthana Mills Ltd. to furnish composition fee and original authorization. Till date M/s. Sri Naga Nanthana Mills Ltd. have not submitted documents as called for. Hence M/s. Sri Naga Nanthana Mills Ltd. was placed under Denied Entities List vide DEL order dt: 04.08.2017. The DEL order addressed to the company has been returned undelivered by postal authorities with remarks "left'.
- 8. In the circumstances, the undersigned is now fully convinced that the licensee and its directors are guilty of violating the conditions of the Licence in question thereby liable to a penalty under Section 11 (2) of Chapter IV of Foreign Trade (Development and Regulation) Act, 1992. In exercise of powers vested in me vide Notification No. SO (E) dt. 17.4.2009 issued by DGFT, New Delhi in F.No. 18/27/HQ/06-07/ECA-II, I hereby impose a penalty of **Rs. 15,79,530** (Fifteen Lakhs Seventy Nine Thousand Five Hundred and Thirty only) on the Licensee and its directors towards non-fulfillment of export obligation in full against the subject authorization.
