APPEAL ORDER

The present appeal dated 06.10.2017 filed by Shri A.Arul Khosh, No. 109, Needarajapaiyer Street, Puducherry 605001 is on account of being aggrieved by decision of CPIO in furnishing information under RTI Act 2005 .

It is seen that the complainant had filed RTI application on 03.08.2017 with CPIO Shri S.Sundararaman, Asst.DGFT, Puducherry. Since the appellant was not satisfied with the information provided by CPIO, the present appeal has been filed. The replies to the questions as sought for by the appellant, are as given below:

S.No.	Query	Reply
1.	Whether he was convicted or acquitted by Special Court on the corruption charges, if convicted, how many years he was sentenced?	Shri A.Arulmany, was convicted by the Special Court and sentenced to undergo rigorous imprisonment for a period of five years under each count (offences u/s 120-B, u/s 7 and 13(2) of P.C. Act, 1988)
2.	If convicted, whether he preferred appeal or not?	Yes, he preferred an appeal
3.	Whether he is in service, produce the joining order	Yes. Joining order enclosed
4.	Whether he is in bail from High Court of Judicature?	He is on bail from High Court of Madras
5.	Whether he is permitted in the bail by High Court of Judicature to move out of Puducherry, if yes, produce the bail order.	The bail granted by the High Court of Judicature at Madras does not mention about his movement out of Puducherry
6.	Has he got permission of the High Court of Judicature to go out of the Jurisdiction of High Court of Chennai?	As stated in S.No.5 above. The bail granted by the High Court of Judicature at Madras does not mention about his movement out of Chennai

7.	Whether the CBI, ACB, Chennai, was informed about his re-entry in service?	No
8.	Whether the CBI, ACB Chennai was informed about his work place after re-entry in service?	No.
9.	If permission from High Court of Judicature was not got and CBI, ACB was not informed about his re-entry in service and place of service, who is authority to be held liable and what departmental action has to be taken over such authority?	Not applicable

Accordingly the appeal is disposed of.
